



Chapter Zero Slovenia represents a **Slovenian Chapter** of the **Climate Governance Initiative**, developed in collaboration with the World Economic Forum.

The aim of Chapter Zero Slovenia is to educate and activate CEOs and non-executive directors of companies in Slovenia to address climate change in their business models by providing them the skills and knowledge that is needed to make climate change a boardroom priority.

It operates on the basis of **8 Climate Governance Principles** and the **Charter of the Climate Governance Initiative**.
